3	Chair's Update
	 Humber Energy Board – meeting in mid-February BEIS Annual Performance Review - 6th February Business Engagement Board – met in January which was well attended. All in agreement a Devolution deal was needed asap and to put pressure on central government to engage with us, agreed that Thomas Martin, Chair of the BEB, would draft a letter to Michael Gove to that affect. NP11 - meeting in December - Roger Marsh to stay on as Chair until replacement is found. Claire Hayward, Cheshire & West LEP, is now the Vice-Chair. NP11 are looking to broaden out their structure to wider regional partnership to include local authorities, universities, etc Convention of the North, 25th January - HEYLEP will be in attendance along with private sector reps and LA Leaders from this area
4	Pan Humber Issues
	Freeport - Latest updates were commercially sensitive so little detail to report at present. The final Business Case would be signed off in the near future, SteerCo were confident that would happen, further details will emerge in due course.
	Opportunity Humber – nothing to report
5	Cllr Michael Ross – Hull City Council
	Updates included:
	Budget Full Council to take place in February and consultation will also take place with business. Budget position is better than originally thought, still placing a hold on recruitment, and replacing all vacancies as arise.



- Westland Docklands was proceeding and was due at Cabinet, keen to get up and running to give improvement to the area along with the provision for the Cruise Terminal Option and option around Ison Leisure with potential new jobs and housing giving a lift in to investment in the area
- Siemens Plant opening which is good for the area alongside this and there is good news around funding starting to come out around the UK shared prosperity funding and some of levelling up grant money. That's going now into the businesses in the city centre, alongside all the doom and gloom out there is also some good news for the city.

- Budget process setting indications from government that there is an expectation that Council tax should go up well 4.99%. 3% for general use and 2% for social care. Own decisions can be made on that, but indications from government is that if you don't put it up by that amount, they will assume that you're financially quite sound and won't need support moving forward in the future expectation to be using reserves – government directive for future
- Workforce issues continue within social care, children and adults
- Discharge from hospital social care leaving acute trusts
- Local elections in May
- Capital Investment programmes important to ensure these are ongoing in uncertain times with inflation and costs rising
- Cost of living crisis has changed the council focus

On 26th May 2022, the LEP Board approved a final budget for the current year following funding announcements from central Government – the HEY LEP was allocated funding of £375,000 for the present year (£500,000 in 21/22).
